This bequest shall become null and void if the hospital shall receive or take a legacy of Five hundred Dollars under will of my husband, Robert Anderson.

Item. All the rest, residue and remainder of my estate I give, devise and bequeath as follows: Unto my said brother, Uriah Boardman, 1/8, unto my said Brother, Thomas Boardman, 1/8, unto my said brother, William Boardman, 1/8, and unto my said sister, Hannah Fleming, 1/8, and the remaining 1/2 to the children of my said brother in law, James Anderson.

Item: I nominate, constitute and appoint my husband, Robert Anderson, and my friend, Rudolph Sachse, as executors of this my last Will and Testament and guardian of the estate of my said grandson, Robert Anderson.
