Barber, I give, devise and bequeath, absolute ly and in fee simple, my garage property on Atlantic Avenue, near Missouri Avenue, Atlantic City, New Jersey, with an outlet on Missouri Avenue; two properties on North Kentucky Avenue, between Atlantic and Arctic Avenues, known and designated as Nos. 23 and 25 North Kentucky Avenue; five/properties on North Kentucky Avenue, near Mediterranean Avenue, known and designated as Nos. 242, 244, 246 and 248 and 250 North Kentucky Avenue; and my property in Mediterranean Avenue, designated as No. 1604 Mediterranean Avenue, Atlantic City, New Jersey.

FIFTH. I give, devise and bequeath to my executor and trustee hereinafter named all the rest, residue and remainder of my estate, intrust, however, for the following purpose:
