I was born in Lehe Germany on the 2nd day of April, anno Domini 1883; I now reside at 118 S. Tenn. Ave. Atlantic City, New Jersey. I emigrated to the United States of America from Bremen Germany on the vessel Karlsruhe; my last foreign residence was Lehe Germany.
