I, John McCann, aged 41 years, occupation laborer, do declare on oath that my personal description is: Color white, complexion medium, height 5 feet 8 1/2 inches, weight 160 pounds, color of hair chestnut, color of eyes chestnut, other visible distinctive marks tatoo mark on right hand. I was born in Glasgow Scotland on the 10th day of January, anno Domini 1875; I now reside at 10 N. Kentucky Ave Atlantic City New Jersey (Give number, street, city or town, and State.) I emigrated to the United States of America from Glasgow Scotland on the vessel Furnessia; my last foreign residence was Glasgow, Scotland. It is my bona fide intention to renounce forever all allegiance and fidelity to any foreign prince, potentate, state, or sovereignty, and particularly to George 5th King of Great Britain and Ireland, of whom I am now a subject; I arrived at the port of New York City, in the State of New York on or about the 19th day of November, anno Domini 1892; I am not an anarchist; I am not a polygamist nor a believer in the practice of polygamy; and it is my intention in good faith to become a citizen of the United States of America and to permanently reside therein:

I emigrated to the United States of America from Naples Italy on the vessel La Veloce; my last foreign residence was Foggia Italy. It is my bona fide intention to renounce forever all allegiance and fidelity to any foreign prince, potentate, state, or sovereignty, and particularly to Victor Emmanuel II King of Italy, of whom I am now a subject; I arrived at the port of New York City, in the State of New York, on or about the 4th day of February, anno Domini 1904; I am not an anarchist; I am not a polygamist nor a believer in the practice of polygamy; and it is my intention in good faith to become a citizen of the United States of America and to permanently reside therein:
