I emigrated to the United States of America from Valerino Italy on the vessel Virginia Brest; my last foreign residence was Sicily Italy

It is my bona fide intention to renounce forever all allegiance and fidelity to any foreign prince, potentate, state, or sovereignty, and particularly to Victor Emmanuel 3rd King of Italy, of whom I am now a subject;
