I emigrated to the United States of America from Genoa Italy on the vessel St Louis; my last foreign residence was Garrara Italy; I am un married; the name of my wife is Elizabeth Monte she was born at Calitsea Mass and now resides at Blackstone Hotel to Virginia Ave Atlantic City.

It is my bona fide intention to renounce forever all allegiance and fidelity to any foreign prince, potentate, state, or sovereignty, and particularly to Victor Emmanuel 3rd King of Italy, of whom I am now a subject; I arrived at the port of New York City in the State of New York, on or about the 10th day of May, anno Domini 1909.
