AN ORDINANCE dividing the Town  
of Hammonton into two Election  
Districts, and establishing the boundary  
lines thereof.

Introduced December 26th, 1896.

Passed February 6th, 1897.

Section 1. Be it ordained by the Town  
Council of the Town of Hammonton, that  
hereafter all that portion of the Town of Ham-  
monton lying south westerly from a line com-  
mencing at a point being the intersection of  
the middle line of a road commonly called the  
"Back Road" and the north westerly bound-  
ary line of the Town of Hammonton, and ex-  
tending thence along the middle line of the  
said Back Road easterly to its intersection  
with the middle line of Third Street; thence  
along the middle line of Third Street to the  
intersection of said Third Street with Maple  
Street; thence along the middle of Maple St.  
southerly to its intersection with the County  
Road; thence along the middle of said County  
Road to the south easterly boundary line of  
the Town of Hammonton, shall be known and  
designated as the First Election Precinct of  
the Town of Hammonton. And all that portion  
of the Town of Hammonton lying northeas-  
terly from the aforesaid line shall be known and  
designated as the Second Election Precinct  
of the Town of Hammonton.

Sec. 2. And be it ordained, That all ordi-  
nances and parts of ordinances inconsistent  
herewith be and the same are hereby repealed,  
and that this ordinance shall take effect im-  
mediately.
