AN ORDINANCE requiring permits to pave
or re-pave, curb or re-curb any sidewalks
in the Town of Hammonton, Atlantic County,
New Jersey.

Introduced July 21st, 1911.

Passed August 17th, 1911.

Section 1. Be it ordained by the Town of Hammonton, in Council assembled, that it shall not be lawful for any person or persons to pave or re-pave, curb or re-curb any sidewalks in any of the streets of the Town of Hammonton without a permit from the Town Clerk, and paying therefor the sum of one (1) dollar.

Section 2. That for each and every violation of this ordinance, the person or persons so offending shall forfeit and pay a penalty of five (5) dollars, to be collected according to law.

Section 3. That all ordinances or parts of ordinances inconsistent with any of the provisions of this ordinance, be, and the same are hereby repealed, and that this ordinance shall go into effect immediately.

Special Council Meeting.

Council Chamber was pretty well filled on Tuesday evening, to discuss (and otherwise) the new paving ordinance before its final passage.

The Mayor being absent, Mr. Wood occupied that seat of honor.

There were but two protests against the proposition, and three or four emphatically for it. The others present seemed to take it as a necessary additional burden, which will eventually greatly increase the value of their property.

The ordinance, providing for further extension of sidewalks and curbs, passed second and final reading unanimously.

Messrs. Waas, Black, and Galigine desired to increase the width of their paving one foot, on Central Avenue, which met with Council's approval.

A letter from the Freeholders, in response to one from Town Clerk Seely, advised the Town Engineer and County Engineer to agree on grades on Egg Harbor Road and Central Avenue, there being an apparent difference.

Clerk was instructed to notify the Gas Company to close holes on Bellevue, as they are dangerous, and prevent the completion of the road building.

By resolution, Clerk was authorized to issue permits to pave and curb, permit good for sixty days unless otherwise provided.

Contract was read, and Mayor authorized to sign it, with Contract or Spear.

Finance Committee was instructed to look after the procuring of money at best terms possible, and report.

WONDERS OF THE VEGETABLE

WORLD.

The fertility of some members of

the vegetable world is really aston-

ishing. Thus, an ounce of onion seed

which was sown in a garden at New-

ton Abbey produced no less than 460

plants, and a single seed of sixty

some idea as to the prolific nature of

vegetables, but it is by no means an

isolated example.

For instance, at Midsbury, a village

near Axminster, an agriculturist

planted an ordinary winter cattle

bean. The average individual, if

asked how many beans made five,

would make a different answer from

that which the agriculturist would

give. His single bean produced no

fewer than 660 beans.

Very extraordinary is the force ex-

erted by growing vegetation. A

curious example of this fact has been

furnished in the gardens at Kelsey

Park, Beckenham. Some twenty days

ago, the workmen and then they found a

mass of mushrooms, only 3 pounds 3

ounces in weight, growing in the cen-

tre of the wall.

Melons are extremely strong in

fact, one has been known to raise a

weight amounting to two and a half

tons. A well-known student of Na-

ture tried to estimate the strength of

a melon when it was eighteen days

old and measured 27 inches in di-

ameter. He fixed a sort of harness

around it, with a long arm or

lever attached, and so was able to

measure the force of the melon by

the weight it lifted at the end of the

arm. The melon, which was only two

days old, was found to exert a

weight of 60 pounds, while seven-

teen days afterwards it actually lifted

5,000 pounds! It is not, however, the

seed of the globe turnip which

measures only about the twentieth part

of an inch in diameter, yet in the

course of a month or two it will en-

large into 27,000,000 times its original

bulk, in addition to the large crop of

leaves.

In fact, by careful experiment it

has been found that a turnip seed,

under favorable conditions, will in-

crease its own weight fifteen times

in a minute. Turnips, which are

grown in the garden, have been found to

increase more than 15,000 times the

weight of their seed in a single day.

By exceptional means, such as by

the use of a microscope, it has been

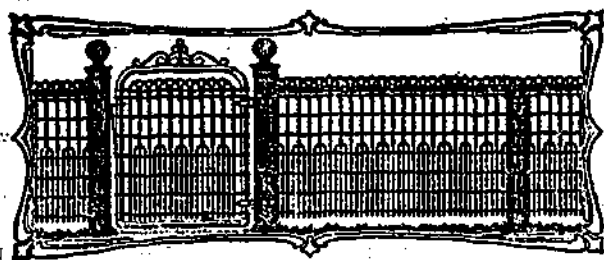
