### CANTEEN.

Colonel Ray, commander at Fort Snelling, says in the St. Paul Dispatch of June 7th: "It is an insult to every officer in the United States Army to say that the army canteen assists in the management of his men. If I had an officer under me who had made such a statement, I certainly would relieve him as soon as possible."

Being asked as to a rumor going around, of the arrest of twelve of his men in a town saloon, he said: "Who told you that story? It is not true. There are people and newspapers hereabouts that tell lies about myself and my post, and the lies are all in favor of the army canteen. I do not see what actuates this sentiment in favor of the canteen. I have searched long to find out what motive the wholesale liquor dealers could have in favoring the re-establishment of the canteen. Their reason must be that in connection with the liquor they sell to the United States they have no license to pay, no saloon-keepers to hire, and are always sure to get their money."

"There is no need of liquor at any army post in the country. Do they have a bar at your newspaper office [this to a reporter], in order to regulate the drinking of the reporters and editors? In your department stores, is a bar maintained simply because a clerk here and there is liable to leave his work, go outside and get drunk?"

If the majority of army officers were like Col. Ray, the recent order of Gen. Miles, Commander-in-Chief, that the law in regard to the Canteen must be enforced, would meet with a ready response, and the law would be given a fair chance. PRESS SUPP.

## The President Shot.

About five o'clock last Friday afternoon as President McKinley stood in the Temple of Music at the Pan-American Exposition, Buffalo, N. Y., shaking hands with all who approached him, he was shot twice, one bullet making but a slight wound in his breast, the other entering his body lower down, and piercing both walls of his stomach. The evil deed was done by one who was in the line approaching Mr. McKinley. His hand was covered with a handkerchief, thus hiding a revolver of large calibre, which was raised and fired as the President extended his hand in greeting.

The would-be assassin was at once seized, thrown to the floor and pretty roughly handled before the guard rescued him and hurried him off to prison. He proved to be one Leon Czolgosz (call it Sholgosz), a native American of Russian-Polish parentage, a disciple of Emma Goldman, the anarchist.

The excitement was intense, but Mr. McKinley was quickly taken to the hospital, where his wounds were examined, the upper bullet easily extracted, and the stomach perforations closed. Later he was taken to the residence of Mr. Milburn, where he had been entertained during his stay in Buffalo. Here were brought the most skillful surgeons in the United States, and experienced nurses,—all giving him devoted care. From the first, there seemed to be little indication of fatal result; the frequent bulletins given out each day were encouraging; and on Tuesday the surgeons stated that "the danger line is passed, and unless unforeseen complications set in, the patient will speedily recover."

The country was shocked when the first telegrams announced the dastardly attempt to murder our Chief Magistrate, and a wild demand for vengeance upon the assassin arose, as the voice of one man. The papers were eagerly sought out on Saturday morning, and a heartfelt thanksgiving went up from every loyal heart for the cheering news. Sunday, telegrams were sent to the Churches, morning and evening, and special prayer was made for the President's recovery.

This act is believed to be the culmination of a conspiracy among the too numerous Anarchists. The assassin himself says he was "inspired by Emma Goldman, the noblest woman on earth." The question is being agitated as to what can be done with these public enemies in private life. There is no law that will reach them directly; but popular opinion says that an Anarchist is the enemy of all civil government, hence the enemy of this government, therefore a traitor,—and treason is punishable by death.

There is too much liberty in the United States. "Free speech and a free Press" are all right when not abused; but there should be a legal limit. A free speech may fire its hearers, and criminal actions result. The persistent advocacy of a wrong course of action, by a public newspaper, may "inspire" some weak or evil minded man to carry out the ideas suggested. We believe that laws should be enacted to suppress all harmful things,—those poisonous to the mind as well as deleterious foods. "Freedom" means too much, to some people, and they carry it dangerously far. The only remedy seems to be, to curtail the privilege, that no abuse may be made of it.

Now, while the world is watching that bad-chamber in Buffalo, is the time to make treason odious,—whether manifested in word or deed, whether expressed on the platform, on the printed page, or in the flash and roar of gunpowder.

We can understand the sentiment that prompted Booth to kill President Lincoln in 1865. The bitter feelings engendered by the war just closed were embodied in the mind of one who sympathized with the defeated cause. Yes, and the strife between factions of the

Republican party brought out strong words and threats which may have given Guitau his idea of "removing" President Garfield in 1881. But the attempted assassination of President William McKinley is without a shadow of excuse. The country is united as never before; all classes of men are sharing in the general prosperity brought about during this man's administration; he has been discreet, wise, considerate, a friend to every man—rich or poor,—has made no enemies; is esteemed by all, even those who oppose some of his public acts.

It was a deed prompted by ignorance and false teaching, and by a man whose parents came to America to enjoy its freedom and opportunities to live in safety and comfort. It is worthy of note that the Anarchists are, almost without exception, men of foreign birth or parentage,—men who should rather be loyal because of gratitude to a government which protects and sustains them. To our mind, this deed affords another argument against unrestricted immigration. Such people are much more dangerous to society than are the Chinese, who are forbidden to land upon our shores. Another problem for our Statesmen.

Thursday night, President McKinley suffered alarmingly, caused, the doctors said, by their mistake in giving him a little solid food during the day.

Friday morning, about seven o'clock, the Philadelphia papers posted a bulletin to the following effect: "The President had a relapse this morning, and is lying at death's door. The Cabinet has been summoned, and all the physicians are at his bedside."
