A WARNING.

As there has been much inquiry as to what disposition was made of Mr. Johnson for drunkenness and disorderly conduct, also for interfering with an officer while in the discharge of his duty, and furthermore, what the penalty of the law is relating to the last named offence, I will reply that on the first charge, Mr. Johnson was fined by Justice Prassey; on the second charge, the penalty is eight hundred dollars fine or two years imprisonment, or both. This last charge I still hold over Mr. Johnson, for his good behavior. I have caused this warning and information to be published, not to defame or in any-wise to injure anyone, but that all may know, both young and old, what a grave offence it is to resist an officer of the law.

Major General Brooke has been designated by the President as Military Governor of Cuba, a post which carries with it full control of the military and civil affairs throughout the island, as heretofore exercised by the Spanish Captain-General. Each one of the six provinces of Cuba will have its own military governor, who will receive his instructions from Gen. Brooke, and be answerable to him.

There has been a good deal of friction between the Spanish soldiers and the Cubans in Havana, in consequence of which there have been two savage affrays, resulting in the killing and wounding of a number of people. In order to prevent further outbreaks, and to protect American citizens now in Havana, a strong naval force, consisting of the Brooklyn, Texas, Castine, and Resolute, has been ordered to the Cuban Capital.

Two sons of a wealthy Filipino visited President McKinley on Monday. They informed the President that their family had assisted Aguinaldo with a view to the annexation of the Philippines to this country, and stated that they did not favor independence. This is undoubtedly the position of the bulk of intelligent Filipinos. Aguinaldo desires independence in order that he may rule over the islands as dictator, but the civilized portion of the population is against him.

Gen. Calixto Garcia, the distinguished Cuban commander, and head of the Cuban Commission to this country, died on Sunday morning, in Washington, after brief illness with pneumonia. In the death of Gen. Garcia, Cuban patriots have lost their ablest and most unselfish leader, who lived to see his country free from Spanish rule, but did not share its hoped-for independence. His body will be shipped to Cuba in an American warship, and with a military guard of honor.

The Peace treaty with Spain was signed by the commissioners of both countries, last Saturday, 11th, in Paris. This insures to this country possession of Porto Rico and the entire Philippine group. There can be no reasonable hope on the part of opponents of annexation that this decision of the administration and peace commission will be reversed. Practically, the islands now belong to the United States, and the treaty will probably be ratified before Congress adjourns.

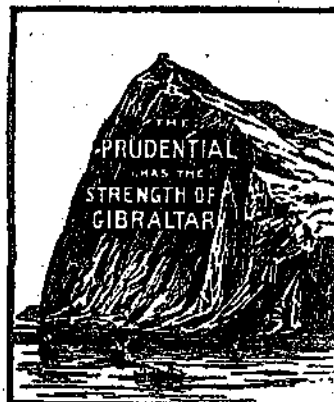

Here's a paragraph cut from the Atlantic Review. It contains several remarkable statements, and omits what is equally important:

"Sydney Rosenbaum, who is at Hammonton, writes his father, auctioneer J. Rosenbaum, that he heard the fire bell ringing at 5:30 Tuesday morning and arose. The fire was a very small affair at that time and burning in a corner of the roof. At 7:30, exactly, the Independence Fire Company passed the house where Mr. Rosenbaum was staying and on arriving at the scene of the fire were surprised to find it out. The house had been totally destroyed."

In Monday's city papers we find an account of certain Sunday happenings which read as follows:

Three venturesome skaters nearly lost their lives by drowning in the Hammonton Lake this afternoon. Only a portion of the lake was frozen over, but the ice was crowded to the full capacity. Along towards noon the sun began to weaken the ice, yet none took warning and fully three were in a crash and Miss Cora Beard and her companion, Fannie Treat were seen struggling in the icy water. Treat gallantly gave his aid to Miss Beard and succeeded in patching her upon solid ice. Thus he managed to keep afloat until a board was reached and he was pulled out.

Nearly at the same time and but a few feet away Joseph Herbert broke through the ice. Owing to the excitement caused by the mishap of Treat and Miss Beard no one saw him as he sank beneath the ice.

It was only after Herbert was submerged several times and nearly exhausted that assistance came, and he was rescued in a somewhat comical condition. The accident broke up skating for the day.

Pretty good story, too bad to mar it, but the first case happened on Saturday, it was in a shallow place, and as the young people stood on the bottom, with the water only waist deep, there was scant opportunity for a display of heroic gallantry. The other incident, we understand, did occur on Sunday, and the young man came up near drowning as did the others. What kind of correspondents do these papers employ?

It is not a mere gathering of biographies of persons who were willing to pay a big price for their own praise, but a history written for preservation. It is illustrated with forty-five pictures of prominent places and persons, bound in clear type on good paper, contains 480 octavo pages, bound in cloth.
